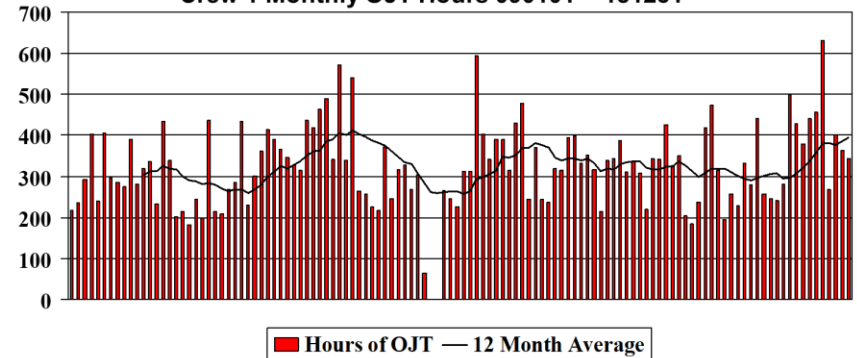

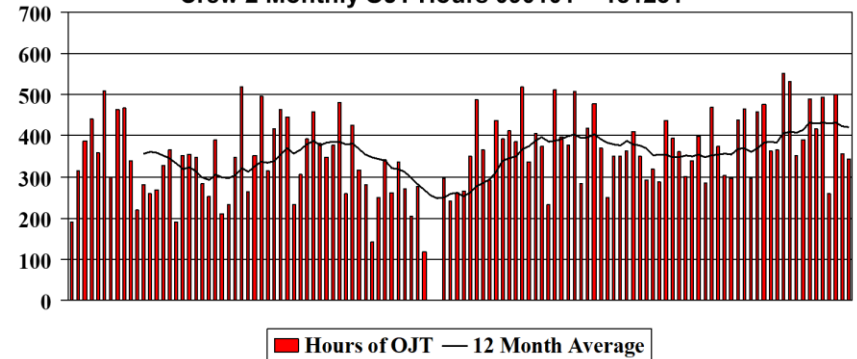

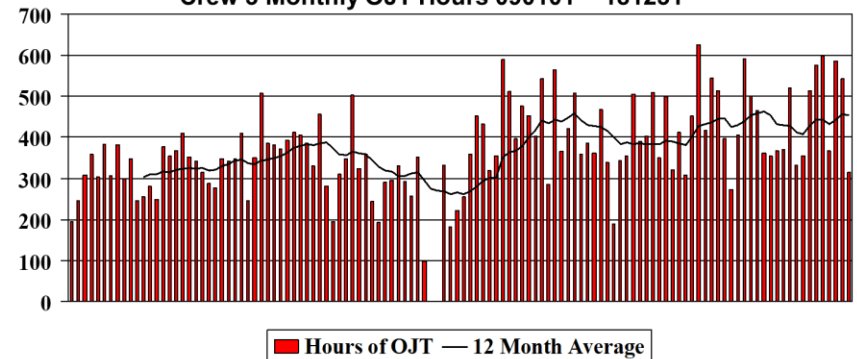
Crew 1 Monthly OJT Hours 090101 – 181231

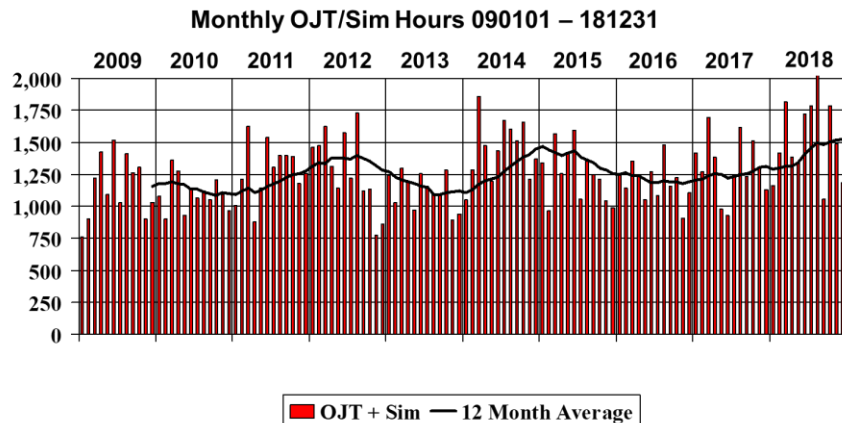
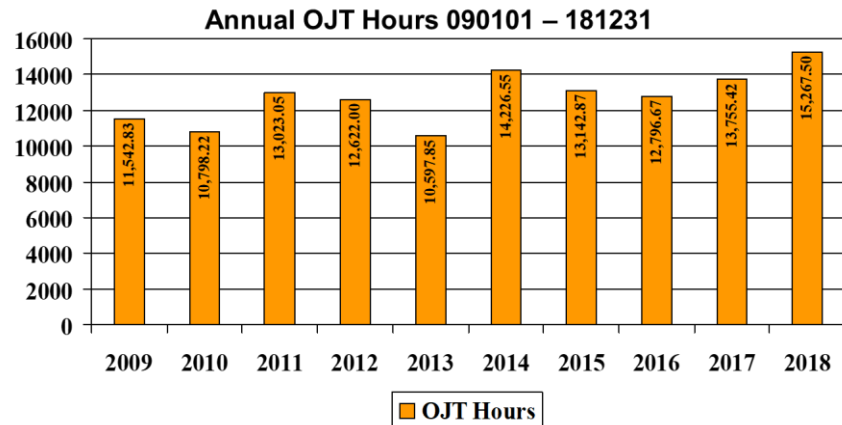
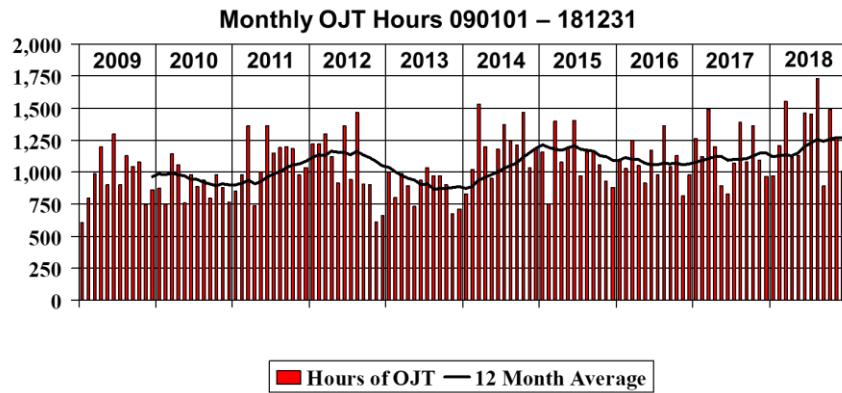


Crew 2 Monthly OJT Hours 090101 – 181231
